

ORDINANCE NO. 2024-0008

AN ORDINANCE REPEALING ORDINANCE NO 02082022 OF THE CITY OF HONEY GROVE AND ESTABLISHING WATER AND SEWER RATES FOR CUSTOMERS; PROVIDING FOR THE REPEAL OF CONFLICTING ORDINANCES; PROVIDING A SEVERABILITY CLAUSE; AND PROVIDING AN EFFECTIVE DATE.

Therefore, be it ordained by the City Council of the City of Honey Grove, Texas:

The water and wastewater service rates adopted herein are effective October 2024.

SECTION 1: Water Service Rates.

Customers Located Inside the City Limits of the City of Honey Grove:

- \$26.50 minimum per month for any active water meter up to 1,999 gallons
- \$3.80 per 1000 gallons of water metered 2,000 gallons – 4,999 gallons.
- \$4.00 per 1,000 gallons of water metered 5,000 – 9,999 gallons.
- \$5.50 per 1,000 gallons of water metered 10,000 – 29,999 gallons.
- \$8.50 per 1,000 gallons of water metered 30,000 – 50,000 + gallons.

Non-Residential Customers, Multifamily Residential with Master Meters, and Housing Authority of Honey Grove:

- \$26.50 minimum per month for any active water meter up to 1,999 gallons
- \$3.80 per 1000 gallons of water metered 2,000 gallons – 4,999 gallons.
- \$4.00 per 1,000 gallons of water metered 5,000 – 9,999 gallons.
- \$5.50 per 1,000 gallons of water metered 10,000 – 29,999 gallons.
- \$8.50 per 1,000 gallons of water metered 30,000 – 50,000 + gallons.

Commercial Customers Inside the City Limits of the City of Honey Grove:

- \$27.50 minimum per month for any active water meter up to 1,999 gallons
- \$3.80 per 1000 gallons of water metered 2,000 gallons – 4,999 gallons.
- \$4.00 per 1,000 gallons of water metered 5,000 – 9,999 gallons.
- \$5.50 per 1,000 gallons of water metered 10,000 – 29,999 gallons.
- \$8.50 per 1,000 gallons of water metered 30,000 – 50,000 + gallons.

Customers Located Outside the City Limits of the City of Honey Grove:

- \$59.50 minimum per month for any active water meter up to 1,999 gallons
- \$.48 per 100 gallons of water metered over 1,999 gallons.

SECTION 2: Sanitary Sewer Service Rates.

Residential Customers Located Inside the City Limits of the City of Honey Grove (Single Family and Multifamily Residential Customers with Individual Meters for Each Unit:

\$45.00 minimum for the first 1,999 gallons of water metered.
\$4.00 per 1,000 gallons for 2,000 – 4,999 gallons of water metered.
\$8.00 per 1,000 gallons for 5,000 – 9,999 gallons of water metered.
\$14.00 per 1,000 gallons for 10,000 – 29,999 gallons of water metered.
\$16.25 per 1,000 gallons for 30,000 – 50,000 + gallons of water metered.

Residential Customers Located Outside City Limits of the City of Honey Grove (Single Family and Multi-family Residential Customers with Individual Meters for Each unit:

\$45.50 minimum for the first 1,999 gallons of water metered.
\$4.00 per 1,000 gallons for 2,000 – 4,999 gallons of water metered.
\$8.00 per 1,000 gallons for 5,000 – 9,999 gallons of water metered.
\$14.00 per 1,000 gallons for 10,000 – 29,999 gallons of water metered.
\$16.25 per 1,000 gallons for 30,000 – 50,000 + gallons of water metered.

Commercial Customers Located Inside the City Limits of Honey Grove with Individual Meters for Each Unit:

\$45.00 minimum for the first 1,999 gallons of water metered.
\$5.00 per 1,000 gallons for 2,000 – 4,999 gallons of water metered.
\$9.00 per 1,000 gallons for 5,000 – 9,999 gallons of water metered.
\$15.00 per 1,000 gallons for 10,000 – 29,999 gallons of water metered.
\$17.25 per 1,000 gallons for 30,000 – 50,000 + gallons of water metered.

SECTION 3: Repeal of Conflicting Ordinances. All existing ordinances of the City of Honey Grove, Texas are hereby repealed in so far as they may be inconsistent with the provisions of this ordinance.

SECTION 4: Severability Clause. If any section, paragraph, sentence, clause, or phrase of this ordinance shall be held unconstitutional or invalid for any reason by a court of competent jurisdiction, such holding shall not affect the remainder of this ordinance nor the context in which such provision so held invalid may appear to the extent that an entire ordinance, section, paragraph, or sentence may be inseparably connected in meaning and effect with the provision to which such holding shall apply directly.


SECTION 5: Publication and Effective Date. This Ordinance is effective as of the date of passage or as of the date of publication if required.
